INSTRUCTIONS

FOR COMPLETION OF "APPLICATION FOR CERTIFICATION OF LEAD-BASED PAINT FIRMS".

PURPOSE

An Application for Certification of Lead-Based Paint Firms shall be submitted in order to receive a Mississippi certificate of approval for a firm conducting lead-based paint activities per Chapter II of the Regulations for Lead-Based Paint Activities.

PREPARATION

All information is to be filled out completely, typed or printed in ink. Pencil is not acceptable.

INSTRUCTIONS

Enter the firm's full name, street address, city, state, and zip code as it should appear on the certificate of approval. Please add the mailing address if it is different than the street address.

Enter the firm's telephone and fax numbers complete with area code.

The firm's representative should read the affidavit carefully. If a firm does not use certified individuals to perform lead-based paint activities or does not conduct lead-based paint activities in accordance with all applicable local, State, and Federal regulations, the Program may revoke the firm's certification. If any misinformation is found to exist in the application, the firm's certification may be subject to revocation.

The application must include a letter attesting that the firm shall only employ appropriately certified employees to conduct lead-based paint activities, and that the firm and its employees shall follow the work practice standards in Chapter III of the Regulations for Lead-Based Paint Activities for conducting lead-based paint activities.

The application shall be signed and dated by the firm's representative. Applications without signatures will not be reviewed.

List up to 2 Certified Renovators associated with this Firm that will be exempt from the Renovator Certification Fee.

Please refer to Chapter II of the Regulations for Lead-Based Paint Activities.

REQUIRED SUPPORTING DOCUMENTATION

Enclose a check or money order for \$350.00 for certification as an abatement firm or renovation firm or \$500.00 for certification as both an abatement firm and renovation firm.
