Dear Ms. Hamel:

The Mississippi Department of Environmental Quality (MDEQ) has received your letter stating that clean-up efforts will be directed toward the Puckett Street Properties in the next few weeks. In order to expedite remediation of these areas, the MDEQ will not require a separate remediation work plan for these areas. Borg Warner may accomplish clean-up of the Puckett Street Properties under the *Drainage Channel Remediation Work Plan*, as approved by the MDEQ on July 24, 2003, with the following conditions:

1. The most recent version of the Site Safety Plan (thru Amendment #002, dated February 20, 2004) shall be used for all work.
2. If significant variations to the approved work plan become necessary, MDEQ approval shall be requested as soon as time and conditions permit.
3. The MDEQ will be informed at least two (2) weeks prior to conducting any field work associated with clean-up of the Puckett Street Properties.
4. The MDEQ will be provided the appropriate number and type of containers for any split samples requested.

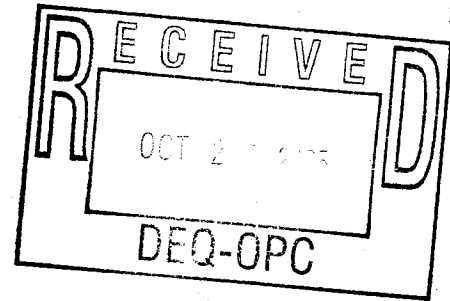

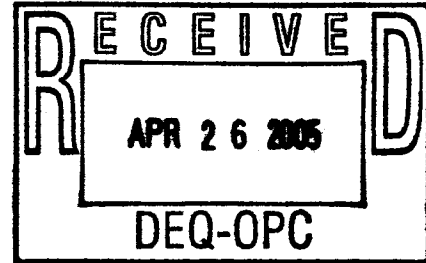

**Re: Puckett Street Soil Sampling**

Dear Mr. Russell:

This is to update the Mississippi Department of Environmental Quality (MDEQ) on the soil-sampling events in Crystal Springs, Mississippi.

As you are aware, BorgWarner conducted two separate soil-sampling events in conjunction with Plaintiffs' consultants and after obtaining access permission from Plaintiffs. The first sampling event took place on January 17, 2005 and centered on the 106 Puckett Street property. The second sampling event took place on February 25, 2005 and incorporated the 104, 106 and 108 Puckett Street properties.

BorgWarner is in the process of evaluating the analytical results that were obtained from both sampling events and plans to compile those results for submittal to MDEQ. BorgWarner also plans to submit with the results a Site Characterization Work Plan describing the sampling activities for the 104, 106, and 108 Puckett Street properties as well as the continuation of the delineation activities.

BorgWarner is currently attempting to identify the property owners to the north and west of 106 and 108 Puckett Street properties to request permission to sample and will notify MDEQ of the sampling date.
