A training program shall not provide, offer, or claim to provide Commission accredited training courses without applying for and receiving accreditation from the Commission as required under paragraph B of Rule 9.3 of the Regulations for Lead-Based Paint Activities and maintaining accreditation by complying with the renewal and re-accreditation requirements of paragraphs F. and L. of Rule 9.3 of the Regulations for Lead-Based Paint Activities.

A completed application shall consist of Parts I-IV of this application form. Any item not submitted shall constitute an incomplete application and the application will be returned without being processed. All information is to be typed or printed in ink.
